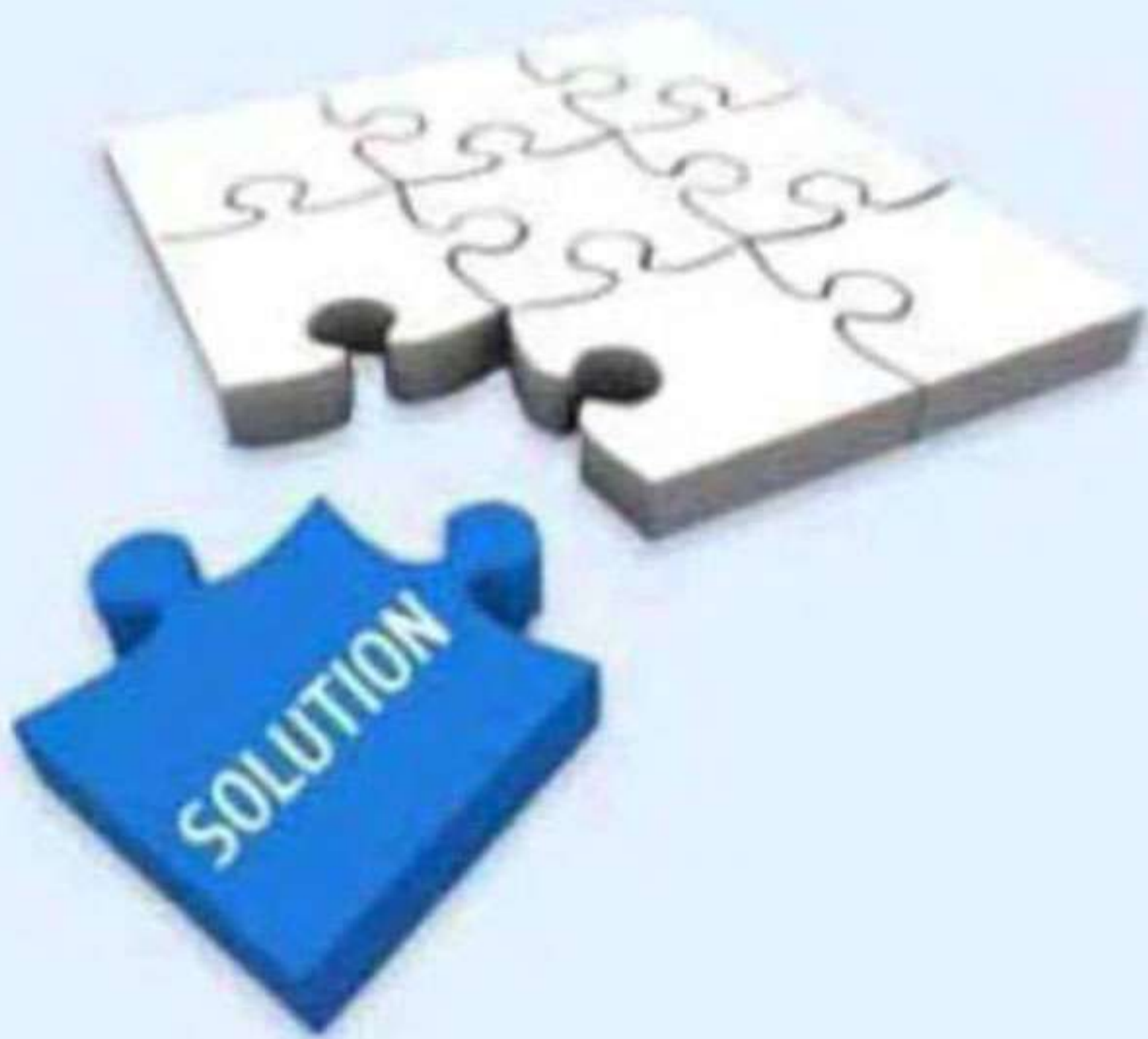




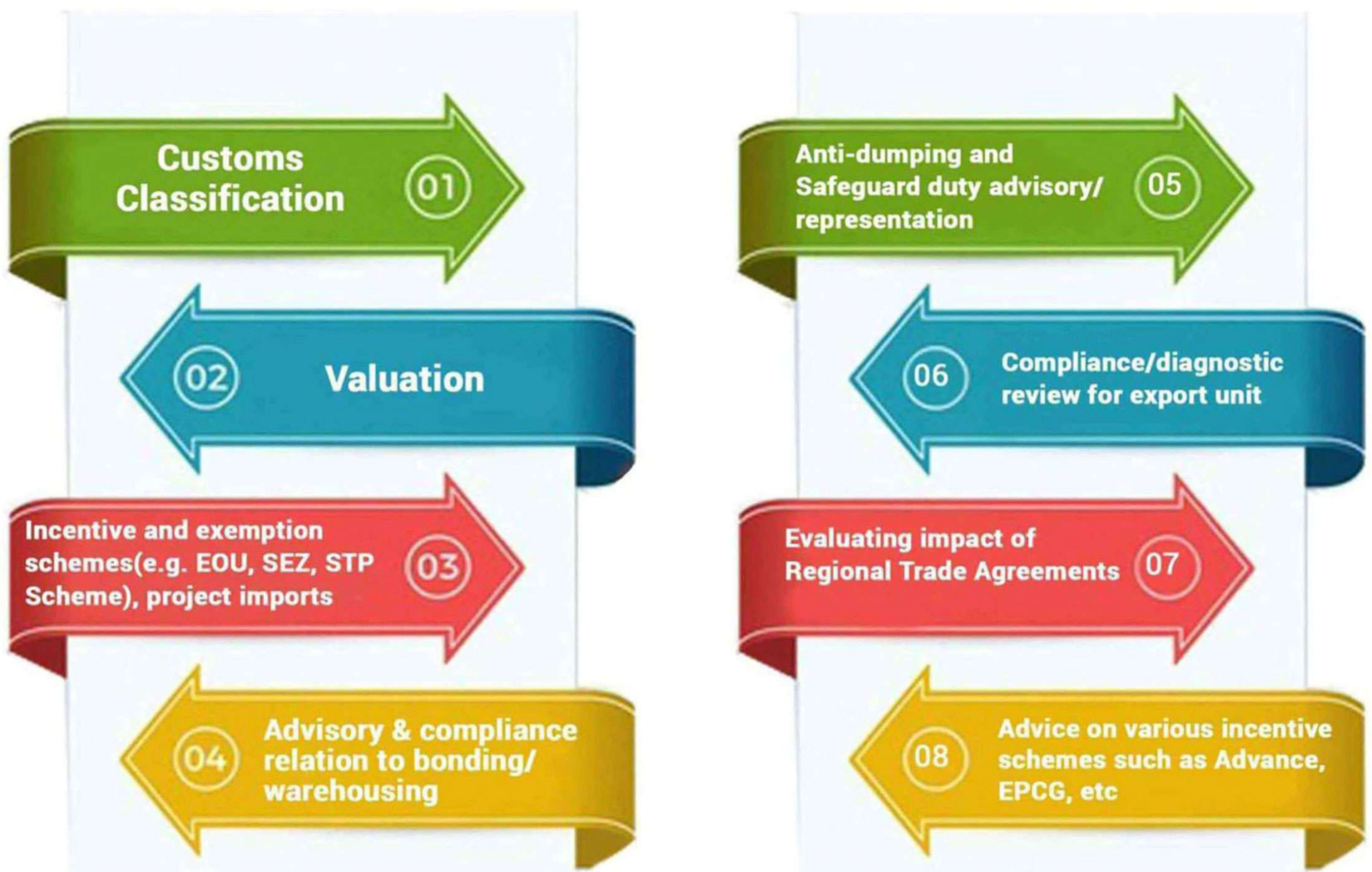

## International Transactions

The impact of customs duties is significant on cross-border transactions. The trend today is reducing customs duties in accordance with WTO commitments. However, the nature and form of tariff and non-tariff barriers is changing rapidly. Regional Trade agreements are increasingly being entered into India.



Upfront identification of the impact of customs duties as well as tariff and non-tariff barriers and regulatory approvals that may be required is critical if imports are an important part of your supply chain. We assist our clients in addressing issues covering all these areas in a holistic manner, such that there are no hidden costs or surprises. ## Procurement, manufacturing and distribution

In India, the indirect taxes applicable to the procurement, manufacturing and distribution functions are complex since they involve an inter-play of taxes that apply at different stages/transactions and at different levels i.e. central, state and local.



A number of indirect taxes typically apply to transactions in the supply chain, including, Excise duty, Sales tax (including works contract tax and lease tax), Service tax and VAT.

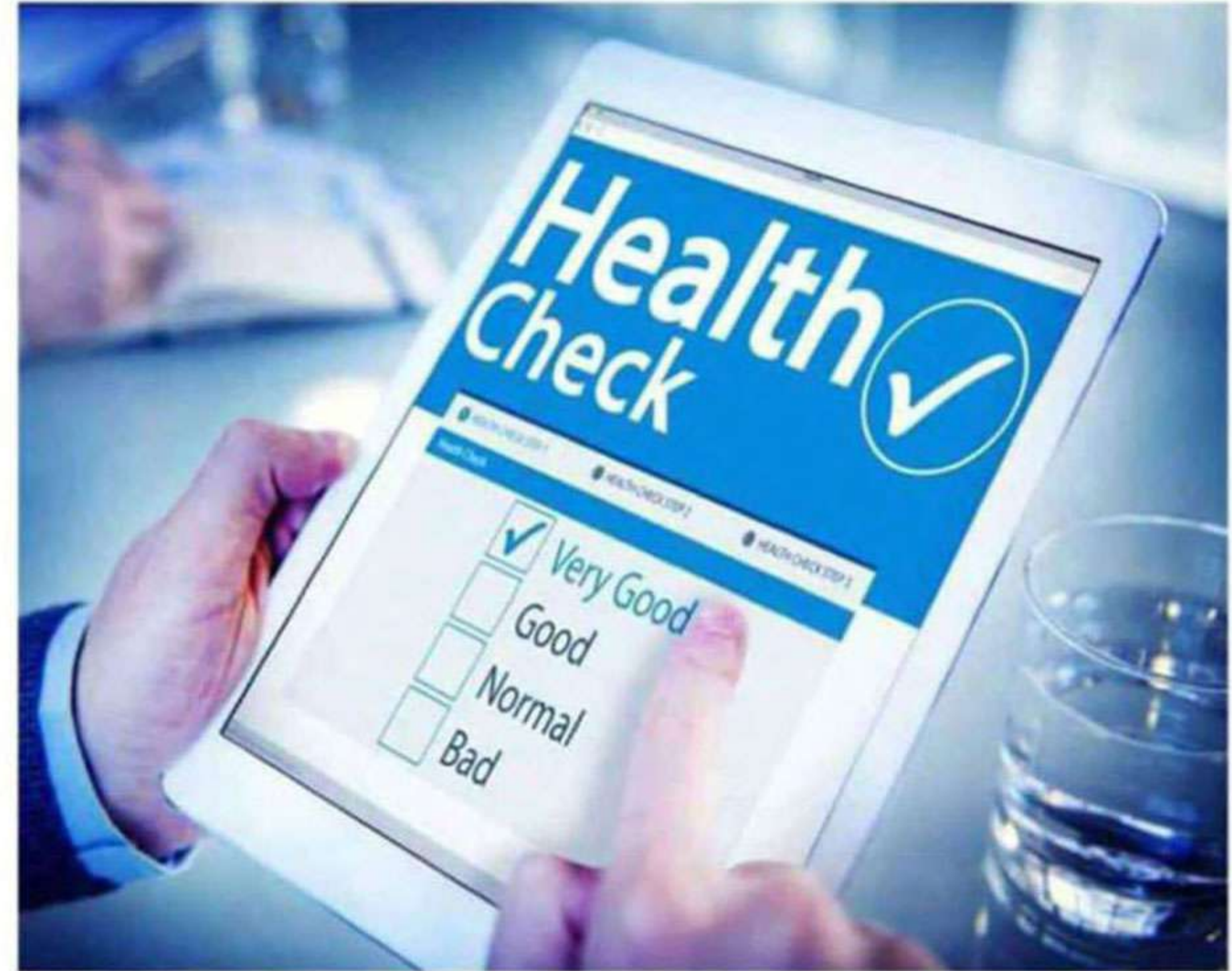
