

D-The following 30 lines are added to the MEIS Schedule. The MEIS benefits for these lines shall, however, be admissible only for the Handicrafts products. If any doubt arises on the issue (whether or not a product is a handicraft item), the DC (Handicrafts) / Export Promotion Council for Handicrafts shall certify that the exported product is a handicraft product. For the non-Handicraft lines of the HS codes, MEIS benefit shall not be available.
